Quarter 2 Water Tolls are due June 30, 2024.

Try to keep the area around your water meter clear.

Easy access to and clear sight of the meter box means less time the meter reader is around your property and more time for us to accurately determine if there is a problem with the meter or the probability of a leak.

Payment Options

- Online banking:
 - Add <u>Cherry Creek Waterworks</u> as a payee.
 - For Quarterly Water Tolls use your account number only (ex.10101).
 - For Parcel Tax, use your account number Plus a P on the end (ex. 10101P).
- Cheques can be put into our mail slot at the office. Please do NOT put CASH in the mail slot.
- Debit/Cheque/Cash in office.
- Pay at your bank.

Please contact the office ASAP to make payment arrangements. Not doing so could result in having your water shut-off.

Wondering when bills are due?

At the Cherry Creek Waterworks office, water bills are sent out quarterly. Expect a water bill to be due at the end of March, June, September, and December. Parcel tolls also are due at the end of September.

- d) \$447.00 on all parcels of land classified as Undeveloped Land.
- e) \$728.00 on all parcels of land classified as Commercial.
- f) \$562.00 on all parcels of land classified as Farm.
- g) \$0.00 on all parcels of land classified as unable to Service/Exempt(connection not readily available).
