3 DELEGATE(S)	Susan Roth, Beaver Creek Electoral Area Director: Question and answer period regarding the Beaver Creek Water Conversion to Regional Service • Susan: Today I am speaking as a former Beaver Creek Water Board Trustee and water consumer; Much like Cherry Creek, we were under the same revisions to VIHA drinking water requirements, due to constant boil water advisories we were required to increase our level of treatment as well as introduce filtration. In the end the decision came down to either "Private or Public" management of the water system via Corix or ACRD. The ACRD said that with conversion we could see possible grant monies for infrastructure. This did not happen, instead they opted to continue the bulk water agreement with the city of Port Alberni, today the city says they are not happy with the current agreement and will be opening it up for discussion and revision. Originally Beaver Creek would have been happy to pay for treatment of Stamp River water. As a Regional Director I will say that an Advisory committee was created to assist the ACRD with decisions regarding the water system, in the past 10 months we have only met twice. Now speaking as a water consumer, I personally think we can join together and incorporate Beaver Creek and Cherry Creek to work together. • Wayne Smith: Who was to blame for increased levels of turbidity in the Stamp River? I seem to remember increased logging in the area that caused it? Also what was the specific incentive from the ACRD to convert to a regional service? • Susan: I believe there was excess logging in the area. The original incentive to convert was the access to grants as well as the ability to borrow money at a low interest rate through MFA (Municipal Finance Authority of BC) those options are not available to Improvement Districts. The Board voted in favour of conversion. After conversion the Advisory committee decided to continue with bulk water rather than treatment. • Mike Sparrow: A note on the bulk water agreement; the water supplier needs to approve n			

- Susan: I am not sure, but I believe they stayed relatively the same.
- Jennifer: Does the city pay more for their water?
- **Susan**: The rates are different; the city pays for their infrastructure as well. Either way residents still would like to go back to Beaver Creek water.
- Robert Babych: Can you go back?
- **Susan**: Yes, all the infrastructure at the pump station is still in place and maintained. Or we could look at different options.
- Lucas Banton: I remember there were some legal issues with the pump station property, do you have information on that?
- Susan: Yes, there were legal battles regarding the property. Currently we pay \$1 per year for the area and are required to maintain the road. The residents are not happy with the noise in the area. I really think we need to take Incorporation seriously; we would have our own access to grants and MFA and maintain control over the area.
- Mike: If you convert to the ACRD you would also have an Advisory Committee, you will not maintain autonomy. Do you know how much the Cherry Creek water treatment will cost?
- Lucas: Hopefully by the end of the year we will have costs, we are hoping for \$5-8 Million, it will include UV, Physical Filtration, and CL2 treatment. The professionals are beginning to put all the information together, Mike, you will be privy to that information once it becomes available. Cherry Creek also began to look into Bulk Water so we could provide two options to the public, it became very clear that our residents were not interested in that option.
- Susan: Think about all the money we can save by working together if we incorporate, we wouldn't need 2 fire departments, we can provide back up water for each other, there are many cost saving options.
- Mike: We would still need 2 fire departments.
- Susan: I would just like you to know there are different options rather than conversion to ACRD.
- Mike: Are there any area reports for Cherry Creek that we need to go over while I am here. I am not sure on the status of the conversion study yet.
- Lucas/Dana: The conversion Study is still currently out for RFP.
- Susan: Lucas, did you investigate incorporation?
- Lucas: When I was the regional Director for Cherry Creek, I did speak to the
 province at UBCM, at that time they were not supportive of incorporation to a
 municipality. Cherry Creek wraps around the city this is not an ideal position
 for a separate municipality. We need to remember other costs of incorporation,
 we would require; a city hall, council, mayor, full staff, road maintenance costs,
 and above 5,000 people we would need to pay for RCMP. We would still
 require a reginal director as well.
- Susan: Lantzville is attached to Nanaimo, and they were able to incorporate?
- Lucas: We cannot compare ourselves to Lantzville, they have a high industrial tax base to fund them, as well as very high property values.
- Susan: I still believe incorporation is an option.
- **Lucas**: My best suggestion if you are passionate about that option is to begin to schedule meetings with the province at UBCM.

- Lucas: I think I was valuable to hear Beaver Creek's side of conversion. Is there anything the board feels we need to investigate or pursue?
- Dana: I would like to reach out to the ACRD and investigate any misinformation during their conversion.

	Lucas: I agree, if there was anything deceiving regarding grants or other			
	promises, that is very concerning.
